Nominating Committee

Shall be composed of representatives of five (5) Regular Members who shall be appointed by the President with the approval of the Board of Directors. A minimum of one and a maximum of two of the membership shall be reserved for active past presidents who are representative of Regular Members. (This requirement may be waived if no past president's quality as representative of Regular Members.)

It shall be the duty of the Nominating Committee to solicit resumes from potential candidates, and to present to the membership at the Annual Meeting a recommended slate members-at-large for election, said slate to be composed of a least one candidate for each position and no more than two. The recommendations of the Nominating Committee shall be published to the regular members by mail or otherwise at least (30) days prior to the annual meeting. The recommendations of the Nominating Committee shall be deemed nominations when the Nominating Committee reports at the annual meeting. After its report to the Members, additional nominations may be made from the floor by a Regular Member. No motion to close nominations shall be taken unless the presiding officer first requests nominations from the floor.

The nominating committee shall also present a proposed slate of officers to the board immediately following the annual meeting. Additional nominations may come from the board after the proposed slate of officers is presented.
