Tournament Rules

Eligibility

- ❖ This tournament will be certified by the USBC.
- ❖ Participation is open to any BCAF member sanctioned center bowlers who are 21 or older by 8/1/19.
- ❖ Current PBA/PWBA members shall not be permitted to complete.
- ❖ The BCAF tournament director has the right to accept or reject any entry.

Averages

- ❖ Averages used for in league qualifiers will be the bowlers highest 2018-19 USBC average of (21) games or more. Those without a 2018-19 USBC average may use their current 2019-20 season average of twelve (12) games or more.
- ❖ Any bowler who fails to report their highest average will result in automatic disqualification from the tournament in accordance with USBC rule # 319a (3).

Handicap

- ❖ Handicap for the state finals shall be 90% of the difference between the bowler's average and 240.

Format

- ❖ Doubles teams shall bowl four (4) games with total pin fall, including handicap, determining the standings.

Multiple Participation

- ❖ Multiple participation shall be allowed at the state finals, however teams with the same members shall only be allowed to cash once.

Payout Ratio

- ❖ 1st place prize money shall be \$2,500.00.
- ❖ Payouts for all other places shall be one (1) in six (6) based on the number of entries.
- ❖ Prize checks shall be paid within 30 days of the conclusion of the tournament.

General Playing Rules

- ❖ This tournament shall only be conducted in a BPAA/BCAF member establishment.
- ❖ Any position ties shall be divided equally in the final standings.
- ❖ The tournament director shall make the decision on all matters not covered by these rules and regulations and all decisions will be final unless an appeal is filed in accordance with USBC rule # 329 (1).
